

## **Notice**

The Jammu and Kashmir Academy of Art, Culture and Languages invites entries for 7th Best Photography Award Competition/exhibition 2015-16 from the professional/ amateur photographers of the state on the following terms and conditions:-

- 1. Entry to the photographic Exhibition /Competition will be open to all the Artists who are state subject.
- 2. There will be following awards for the photographic Exhibits adjudicated as best by the Judging / Selection Committee to be appointed for the purpose by the Secretary.

a.	Best photographic specimen	Rs. 20,000/=
b.	Second Best photographic specimen	Rs. 15,000/=
c.	Third Best photographic specimen	Rs. 10,000/=
d.	Consolation Prize	Rs. $1,000/=$

- 3. Not more than 2 photographs per entrant will be accepted.
- 4. The photographers must be sole author and owner of the Copyright of their entries.
- 5. The Academy reserves the right to accept, reject and not to display any entry without assigning any reason thereof.
- 6. The decision of the Academy on all matters relating to exhibition/competition shall be final and no correspondence will be entertained at any stage.
- 7. The Academy may or may not purchase the exhibits received for the exhibition / competition on the price to be fixed by the committee.
- 8. Late, illegible, incomplete, defaced or corrupt entries will not be accepted.
- 9. No Photograph that infringes the rights of any party or contain any image or content that is in any way unlawful, harmful, threatening, defamatory, obscene, harassing or ethically, or otherwise objectionable will be accepted.
- 10. The minimum size of each photograph should be 10"x12".

- 11. Each entry must include the name, postal address and telephone number and description of the photograph subject matter including when and where the photograph was taken.
- 12. The photographs already displayed in any Exhibition /competition or awarded in any part of the country shall not be accepted.
- 13. The photographs must be suitably framed.
- 14. No photographer will be eligible for more than one prize.
- 15. The Academy reserve the right to reproduce prints of any exhibits accepted for exhibition/competition in its journals, publications etc. Copy right of the art work that may be acquired by the Academy from exhibition shall vest with the Academy.
- 16. The work of Awardees for the next three years will be accepted only for selection /exhibition not for award.
- 17. The awarded work will be the property of the Academy.
- 18. If any question arises relating to the interpretations of these rules, the matter will be referred to the President of the Academy whose decision thereon shall be final, conclusive and binding on the parties.

The specimens be delivered at the Academy's offices at Jammu, Srinagar, Doda, Rajouri, Kargil and Leh or send to the Academy Offices Jammu /Srinagar by registered post. The last date of receipt of entries /specimen has been fixed as 15<sup>th of</sup> March 2016 by 3:00 P.M.
