#### Subject: TERMS AND CONDITIONS for Drama Festival/Competition.

- 1. (a) Only bona-fide amateur theatre groups/dramatic clubs/cultural societies/organizations; envisaging, in their constitution, the promotion of theatre; registered by the Registrar of Societies J&K Govt. under J&K Societies Act-VI of 1998 (Samvat) and recognized by the Academy, should apply, on a proper application form, prescribed by the Academy in this regard, with the below mentioned enclosures:
- (i) One script copy of a full-length play, not less than seventy five minutes of performance time, excluding the time gained in interval, scene or set changing or any other break, duly computerized or written in legible handwriting on A-4 size paper in approved script of the language in which it is written.
- (ii) Permission of the playwright/translator/adaptor allowing the Group to produce the play in the said theatre festival/competition of the Academy. And if the script is adaptation or translation of a play of a contemporary playwright (written within the last fifty years), the original script copy should also be enclosed with the Prescribed Application along-with the permission of the original playwright for translating/adapting the script.
- (iii) Profile of the Playwright/adaptor/translator and his consent/permission letter in favour of the group to produce the play along-with his photograph and address.
- (iv) Profile of the Director of the play/production and his consent letter in favour of the group to direct the play along-with his PP size colour photograph and address.
- (v) Director's note about the production/play and synopsis of the play (not less than 200 words) in English.
- (vi) Profile of the theatre group/dramatic club/cultural society giving its past credentials (at least of the last three years).
- (vii) Attested photocopy of the Registration Certificate of the group issued by the Registrar of Societies along-with the constitution copy of the group/club/society.
- (viii) List of the Executive/Working/Managing/Governing Body of the theatre group / dramatic club / cultural society with complete address and signatures.
- (ix) List of the member artistes of the theatre group/dramatic club/cultural society with complete addresses.
- (i) The script copies, as such submitted, will be sent to the experts for scrutiny and if approved will be entertained for the festival/competition.
  (ii) The festival will be held only if three or more than three groups qualify for the festival from one district.
  (iii) If, from any district, less than three entries qualify for the festival/competition, the Academy may in that case organize the festival by clubbing two to three districts together to ensure three or more than three entries for the festival.
- (c) (i) Original scripts which have been awarded by the Academy in its play-competition shall be given preference.
  (ii) Only one script of one playwright/translator/adaptor will be accepted/ entertained from one group. However another script of the same playwright may also be entertained from another group provided the titles, characters and story of the play is different.
  - (iii) Each play/script must have at least three speaking/performing characters.
- (d) A script which has been produced by the same group/club/society in any festival of the Academy within the preceding five years will not be accepted in any other form whether translation or adaptation in any language.
- (e) Any director who has once produced the script with one group for the Academy festival within the preceding three years will not be allowed to produce the same script for the festival of the Academy with another group. Similarly any actor/actress/ singer/music director or any back stage artiste having participated in a play performance of any group once shall not appear in the same role in the production of the same play/script by any other club/group within the next preceding three years.
- 2. The theatre group/dramatic club/cultural society whose script is selected by the experts shall have to show a full rehearsal of their play, at least ten days before the scheduled date of the festival, to the representatives of the Academy to ensure participation of the group.
  - (i). The Theatre group/dramatic club/cultural society whose script is selected by the experts will be paid production cost of Rs.15, 000/- (Rupees fifteen thousand only) payable after the festival/competition is over, only if the production is not disqualified by the Jury, for the reasons given therein and in that case no claim for the production cost
    - (ii). The director of the production will be paid Rs. 5000/- as fee for direction.
  - (iii). The royalty of original play payable to the playwright will be Rs. 2000/- while as royalty for a translated adapted play will be Rs. 1000/- payable to translator/ adopter.

- 4. No individual director/actor/actress/back-stage worker will be allowed to take part in any category for more than one production entering the festival and if found otherwise, not only the actor/actress/backstage worker but the productions in which he/she would have participated shall be liable to disqualification.
- 5. The Theatre group/dramatic club/cultural society shall have to perform at the Tagore Hall Srinagar / Abhinav Theatre Jammu or at the venue fixed by the Academy, provided with the available Lighting and PAS equipments. The groups/club shall be personally responsible for proper utilization of those equipments and arrangements.
- (a) The Academy will, on the adjudication of the Judges, give the following Awards: 6.
  - First Best Production Rs.10,000/-(Rupees ten thousand) only Second Best production Rs.8000/-(Rupees eight thousand) only (ii)

Prizes in the following categories: (iii)

- Best Direction (Rs.2000/-) Best Costumes (Rs.1000/-) 1.
- Best Make-up (Rs.1000/-) Best Acting (Male) Rs.2000/ 3. 4. Best Music. (Rs.1500/-)
- Best Acting (Female) Rs2000/-5. 6. Best Set Design Rs. 1000/-8. Best Light Design Rs. 1000/-

On the recommendations of the Jury, the Academy may also give a consolation/special prizes (as second prize) of Rs.700/- (Rupees six hundred) one each for the categories enumerated above under clause (iii - 1-6)

Best Child Artiste Rs.500/-(iv)

- Subject to the recommendation/s of the Adjudication Committee, Certificates of Merit for categories (v) enumerated under (iii) to (iv) may also be awarded.
- No prizes shall be awarded in any category if the judges are not satisfied with the required merit of the (b) performance/production. The decision of the Academy in this behalf shall be final and not open to any question whatsoever.
- The merit for the First and Second Best production and direction shall be considered for the award only when the (c) Production/Director secures above 60% consolidated marks in the festival.
- If the production of any theatre group/dramatic club/cultural society is found below the artistic, aesthetic (d) and theatre standards, the particular production could be disqualified by the jury and in that case no claim for the production cost / director's fees / royalty to the playwright / translator / adaptor, as mentioned above will be admissible.
- The First Best Production of the district shall have to participate in a non-competitive Provincial/State Theater (e) Festival at the provincial headquarters for which the group will be paid the production cost/TA/DA according to Academy rules. However the Academy shall extend invitation to the Second Best Production as and where it deems proper.
- 7. The participating group and the director shall be required mandatory to attend, in the morning next day following their performance, an interaction/discussion with the jury members, the observers and other theatre activists who wish to join the interaction session of the festival and failing which the Jury shall reserve the right to consider or not to consider the production of that director/group for any merit.
- If any of the theatre group/dramatic club/cultural society is found to have provided any false/fabricated 8. /wrong information with the Application Form or fake/forged document at any stage of the production, the group and the director shall be liable to be black-listed by the Academy for the next three years at least.
- 9. The right to video shooting/recording of the production by the concerned group will be restricted only to one camera just for their documentation. No multi-camera set for shooting the production will be allowed in any case so as to avoid commercial purpose of the group.
- No Academy employee would be allowed, individually, to participate in the Academy festival, in any **10.** capacity. However this will not apply to them in the category of a playwright.
- The theatre group/dramatic club/cultural society shall be required to submit an undertaking to the effect that: 11.
- The information given in the Application Form is correct and nothing is fabricated or false. The group shall (i) be personally responsible for any thing found otherwise.
- If it failed to present its production in the festival after finalization of the festival schedule and (ii) brochure/invitation cards, the group shall be responsible to pay all costs as may be determined by the Academy.
- The decision of the Academy in all relevant matters shall be final and binding upon the group.
